Troy and Tara Hicks provided an overview of the requested Ag Ari Strip. They provided a map showing its locations. This is strictly an Ag Air Strip. This Ag Air Strip will not appear on any maps. It will be seasonal use. It is composed of soil and grass no concrete or asphalt.

Based on this presentation the individuals who signed in to speak had no further comments as long as it is done in the manner described by Mr. and Mrs. Hicks.

Council Comments

Shawn Buckland - It is a Private Air Strip? Mr. Hicks clarified that it is NOT Private it is an Ag Air Strip and the definitions for these are different.

How many hangers will be constructed? Mr. Hicks clarified that there will only be one hanger and it will also store of equipment that they own.

Mayor Allen - How often will you be taking off from this strip? Mr. Hicks stated maybe taking off and landing 10 time in a week. It could be a bit more in the fall.

Bret Novik - What time do you take off and how loud is the plane? Mr. Hicks stated we would take at sunrise. The plane cannot be heard 1.45 minutes after take off and the landing is also quiet. Take off to the northwest, it climbs 1000ft per minutes and at 500 feet you re in air space.

A final decision on this request will be made at the April City Council Meeting.


