Public Comments:

Steve Ellsworth - Presented the overview for the owner. Mr. Ellsworth stated that they are not going to use Mallard as a connection.

Mayor Manwaring read the letter of concern from John Sadusky and Mike Caldwell. Mayor Manwaring also read the requirements for a buffer in our current ordinance.

Mayor Manwaring also discussed the Road Access questions and what that means for access.

Ron Frazeel - What will the ground be used for? Jay Rice stated they are thinking about Fishing Cabins. Question regarding Highway 26 access. Access to Mallard will be a possible issue. If the Swan Springs roads are used will there be any compensation for this?

Ken Eastman - Does not want Mallard used as a connection.

David Johnson - Does not want Mallard used as a connection. The Survey shows that this is not wanted. The buffer is only 10 feet and it is not a buffer. Commercial development should not go up against residential.

Mike Fincher - LandScape Buffer and when the commercial project will have to have approval. Concern of Light Pollution with commercial property. Conditional approval so that Mallard Lane is not used.

Tammi Wilkins - Same feelings as the others regarding this issue. Would not be in favor of a berm. If it is approved there will be strong conditions.

Marc Nelson - Question on the actual position of the land. The congestion is getting worse. Without knowing the whole plan it is concerning.

Swan Valley City Council Comments:

Mayor Manwaring presented an overview on the facts for holding a public hearing. I would not recommend that approval be granted if there is any connection to Mallard. The Buffer needs to be established to support this.

Stacy Crnkovich presented an overview of the Comp Plan for the benefit of the attendees. There are many more reviews and approval for development.

Shawn Buckland made the motion to approve the Rezone Bonneville County Parcel Number RPH0000065565. Stacy Crnkovich seconded the motion. The vote was unanimous.
